**Renewing Contract for Diabetic Supplies for Sunny Hill Nursing Home**

WHEREAS, the current contract for diabetic supplies at Sunny Hill Nursing Home with McKesson Medical Supply, Minneapolis, MN expires on August 31, 2022, and

WHEREAS, the current contract allows for the extension of said contract at one year intervals, if the County so chooses, and

WHEREAS, the Purchasing Director and Nursing Home Administrator have recommended, and the Public Health & Safety Committee has concurred, that the contract for diabetic supplies for Sunny Hill Nursing Home with McKesson Medical Supply, Minneapolis, MN be renewed for one year from September 1, 2022, through and including August 31, 2023. The contract amount will be approximately \$7,053.91 as stated in the original bid documents, and

WHEREAS, sufficient appropriations have been budgeted for this purpose.

NOW, THEREFORE, BE IT RESOLVED, that the Will County Board hereby authorizes the County Executive to renew the contract for diabetic supplies at Sunny Hill Nursing Home with McKesson Medical Supply, Minneapolis, MN, for one year, September 1, 2022, through and including August 31, 2023.

BE IT FURTHER RESOLVED, that the Preamble of this Resolution is hereby adopted as if fully set herein. This Resolution shall be in full force and effect upon its passage and approval as provided by law.

Recommendation from Maggie McDowell, Administrator of Sunny Hill Nursing Home, is to go with the low bidder, McKesson Medical Supply, for an approximate total bid price of \$6,780.00 for the 1<sup>st</sup> year. The cost for optional 2<sup>nd</sup> and 3<sup>rd</sup> years, if considered at that time, will increase to \$6,915.60 and \$7,053.91, as the vendor listed a 2% **increase** on their bid form. If extended, grand total for all three (3) years will be \$20,749.51

These totals could vary depending on resident population and need. The contract period will begin September 1, 2020 through August 31, 2021, with two (2) optional one (1) year renewals.



Regarding Diabetic Glucose Monitoring Supplies for Sunny Hill Nursing of Will County:

Two bids were received for services that would provide Sunny Hill residents with diabetic glucose monitoring supplies to include the provision of test strips and blood lancets.

Our current Diabetic Glucose Monitoring supplier, Medline Industries, Inc, bid on supply provision, at a grand total, for all three contract years of \$22,769.10

The other bidder was McKesson Medical-Surgical Government Solutions LLC, whose bid for diabetic glucose monitoring supplies for all three contract years was \$20,749.51

Therefore, I am recommending that the Diabetic Glucose Monitoring Supplies bid be awarded to McKesson Medical-Surgical Government Solutions LLC, based on the overall cost of these necessary supplies for our residents.
