

Recommendation from Maggie McDowell, SHNH Administrator, is to split the award of this bid to **two (2) bidders**, for an approximate first year annual cost of **\$61,553.76**, as stipulated in the bid document; **Medline Industries, Northfield, IL**, for an approximate cost of **\$56,897.58**, and **Dispose N Save, Monroe, NY**, for an approximate cost of **\$4,656.18**.

The contract begins May 1, 2022 through April 30, 2023, with two (2) additional one (1) year renewal options, at the discretion of Will County. These costs are approximate, based on resident population and needs and includes consideration of 2<sup>nd</sup> and 3<sup>rd</sup> year increase in pricing, as allowed in the bid document.

Regarding RFP #2022-29 Nursing/Dietary products for Sunny Hill Nursing of Will County:

Predominantly, there exists only ONE bid with a SECOND bid for a select number of products (2), submitted received, and accepted by the Will County Purchasing Department for services that will provide Sunny Hill Nursing home with Nursing/ Dietary products due to a bid renewal process and current contract expiration.

Based on a very limited selection option and elevated prices as compared to former bids, selections are as follows:

**DISPOSABLE SANDWICH BAG – Year Quantity/12 – UOM/BX - Pack Size – 1000**

BY: 1. Medline - \$36.26 - \$435.12

2. Dispose N Save - \$12.84 - \$154.08

Therefore, I am recommending that the Nursing/Dietary product – **DISPOSABLE SANDWICH BAG** be awarded to Dispose N Save in the amount of \$36.26 = \$435.12 with an optional Year Two (2) percentage increase of 0% and an optional Year Three (3) percentage increase of 0%. Lead time ARO is 2 days.
