These costs are approximate, based on resident population and needs and includes consideration of 2^{nd} and 3^{rd} year increase in pricing, as allowed in the bid document.

Regarding RFP #2022-29 Nursing/Dietary products for Sunny Hill Nursing of Will County:

Predominantly, there exists only ONE bid with a SECOND bid for a select number of products (2), submitted received, and accepted by the Will County Purchasing Department for services that will provide Sunny Hill Nursing home with Nursing/ Dietary products due to a bid renewal process and current contract expiration.

Based on a very limited selection option and elevated prices as compared to former bids, selections are as follows:

DISPOSABLE SANDWICH BAG - Year Quantity/12 - UOM/BX - Pack Size - 1000

BY: 1. Medline - \$36.26 - \$435.12

2. Dispose N Save - \$12.84 - \$154.08

Therefore, I am recommending that the Nursing/Dietary product – DISPOSABLE SANDWICH BAG be awarded to Dispose N Save in the amount of \$36.26 = \$435.12 with an optional Year Two (2) percentage increase of 0% and an optional Year Three (3) percentage increase of 0%. Lead time ARO is 2 days.
