#### Addendum #1 – March 7, 2025

**We received multiple requests for previous bid pricing, please see attached spreadsheet with 2022 awarded pricing noted.**

**We received the following questions regarding this RFQ:**

Question #1: Item #6: The specified size is 30"x47" 20 gallon. A typical 20-gallon can liner usually measures 30"x37" or 30"x36". Please clarify if the specified size is a typo, or you indeed require a 30"x47" liner.

**Answer #1: The size requirements listed are correct, please bid as the form shows.**

Question #2: Item #7: The specified case pack is 1,000 bags/case. A typical 30"x37" can liner usually comes packaged with maximum 500 bags/case. Please clarify if the specified count is a typo, or you indeed require the price per 1000 bags in a case.

**Answer #2: We will accept 500 per case, please ensure you are bidding on the correct total quantity.**

Question #3: The specified case pack is 250 bags/case. A typical 38"x60" can liner usually comes packaged with a maximum of 200 bags/case. Please clarify if the specified count is a typo or if you indeed require the price per 250 bags in a case.

**Answer #3: We will accept 200 per case, please ensure you are bidding on the correct total quantity.**

Question #4: Based on previous ordering history and purchase orders, about how often are the trash liners ordered (Monthly, quarterly or other) and what is an approximate case order? If it is as needed and quantities vary can you please provide the quantity of the last order placed

**Answer #4: With regards to the number of cases ordered, we currently order between 700 to 950 cases of each liner yearly, with the current number of liners per case as previously noted.**
