Regarding RFP #2025-25 Exam Gloves for Sunny Hill Nursing Home of Will County:

On 10/22/2024 five (5) bids were submitted and received by the Will County Purchasing Department for proposed services that would provide Sunny Hill Nursing Home with Exam Gloves due to a bid renewal process and current contract expiration.

The first of five bids submitted for consideration was from Medline Industries, Northfield, IL with the first-year grand total amount of \$78,271.44 including a 15% increase in Year # 2 and # 3 respectively. Lead time is two days if product in stock.

The second of five bids was received from Dante Disposables LLC, Westlake Village CA, with the first-year grand total amount of \$66,234.48 including a 3% increase in Year # 2 & # 3 respectively. Lead time is 5-7 days.

The third of five bids was received from Aura Healthcare, Skokie, IL with the first-year grand total amount of \$38,640.00 and no percentage increases in Years # 2 and # 3.

The fourth of five bids was received from Professional Medical, New Lenox, IL with the first-year grand total of \$31,464.00, no increase occurring in Year # 2 and a 3% increase occurring in Year # 3. Lead time is 1 day.

The fifth of five bids was received from Mersi Distribution, Miami, FL. Bid was disqualified due to no Bid Bond.

Therefore, based on the bids submitted the bid for Exam Gloves is being awarded to Professional Medical, New Lenox, IL.

It is critical that the service providers Sunny Hill Nursing Home partners with can meet the variable day to day 24/7 needs of a skilled long term care facility. Service providers must be able to meet the ever-changing needs of our elderly population.
