On Thursday, February 20, 2025, fourteen (14) contractors' bids were received and opened for Roof Replacement and Glass/Glazing for the 1300 Copperfield Avenue Project as follows:

Ten (10) bids for Base Bid 1: Roof Replacement  
Four (4) bids for Base Bid 2: Glazing Repairs

The low bid for Bid 1, Roof Replacement, was submitted by Adler Roofing of Joliet, IL, in the amount of \$270,050.00, with Alternate Add 1: \$36,700.00 and Alternate Add 2: \$18,000.00, for a total recommended award amount of \$324,750.00.

The low bid for Bid 2, Glazing Repairs, was submitted by 3F Corporation of Alsip, IL in the amount of \$118,700.00.

After careful review of the bids in consultation with Paul Pessetti, of Legat Architects, and the Facilities Team, it is my recommendation to proceed with the bids received from both:

Dear Mr. Tkac,

On Thursday, February 20, at 2:00 p.m. bids were received for the above referenced project in the Purchasing Department. Ten (10) sealed bids were submitted for Base Bid 1: Roofing Replacement and Four (4) sealed bids were submitted for Base Bid 2, Glazing Repairs. All bids were considered responsive. The bid opening was conducted by Kevin Lynn, Purchasing Director, Nancy Ruettiger and witnessed by thirteen (13) attendees. Refer to the attached Bid Sign-In Sheet.

The project was broken into two base bids. Base Bid 1, for Roofing Removal and Replacement at 1300 Copperfield Ave., and Base Bid 2, for Glazing Replacement at 1300 Copperfield Ave. Alternate bids were taken as part of Base Bid 1, for vapor barrier installation, changing the roofing material from 60 mil EPDM to 90 Mil EPDM, and painting of exterior steel at the building entry and entrance canopy as indicated on the Bid Form.

Legat Architects has reviewed the project scope of the apparent low bidder, J.L. Adler Roofing and Sheet Metal, Inc. (Base Bid 1) and 3F Corporation (Base Bid 2) and have confirmed that both are confident with their bid prices and have included all specified work and allowances. Legat Architects further reviewed the qualifications and references of the low bid contractors and found no evidence which would disqualify them from being awarded a contract for the work.

**Base Bid 1:**

Legat Architects recommends that Will County consider awarding the Contract for Construction, inclusive of the Base Bid (\$270,050.00) and Alternate Bid 1 (\$36,700.00), and Alternate Bid 2 (\$18,000.00), for a total contract amount of \$324,750.00, to:

Alternate Bid 3 is not recommended at this time. All work is to be completed by Friday, August 29, 2025.


