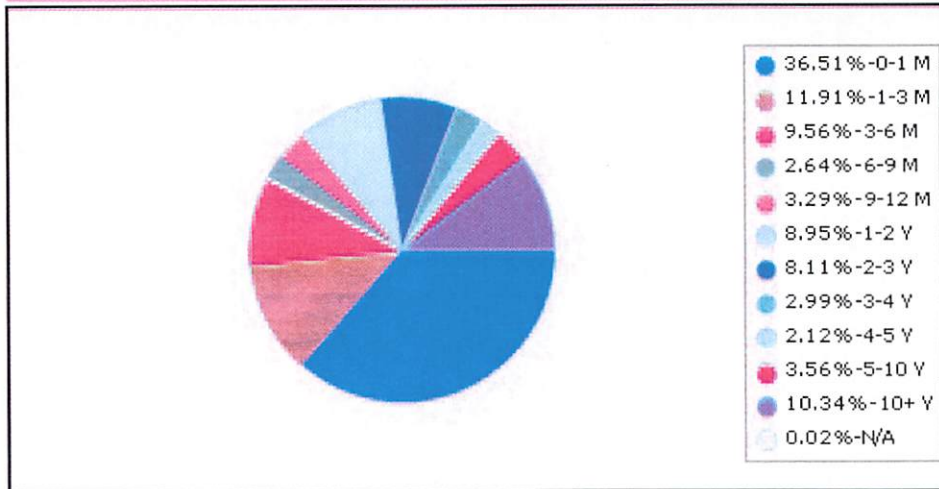
## Will County Distribution by Maturity Range - Market Value All Portfolios

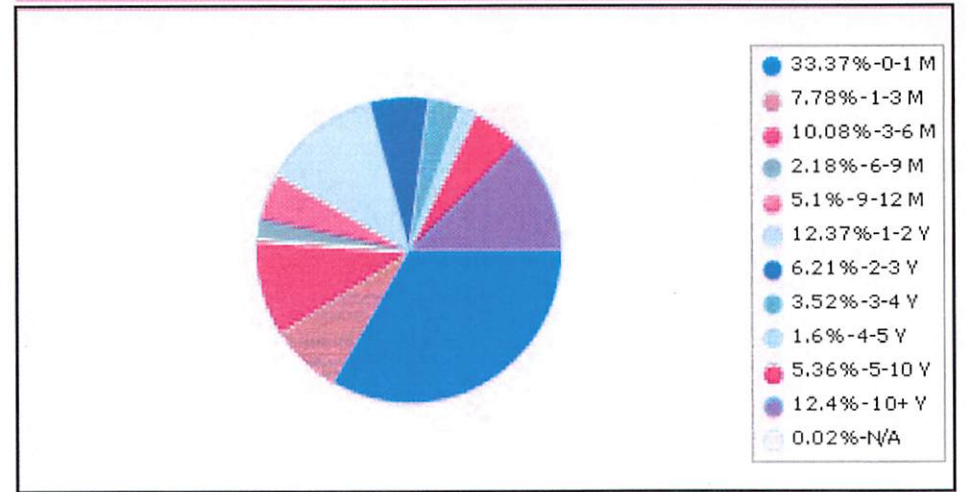

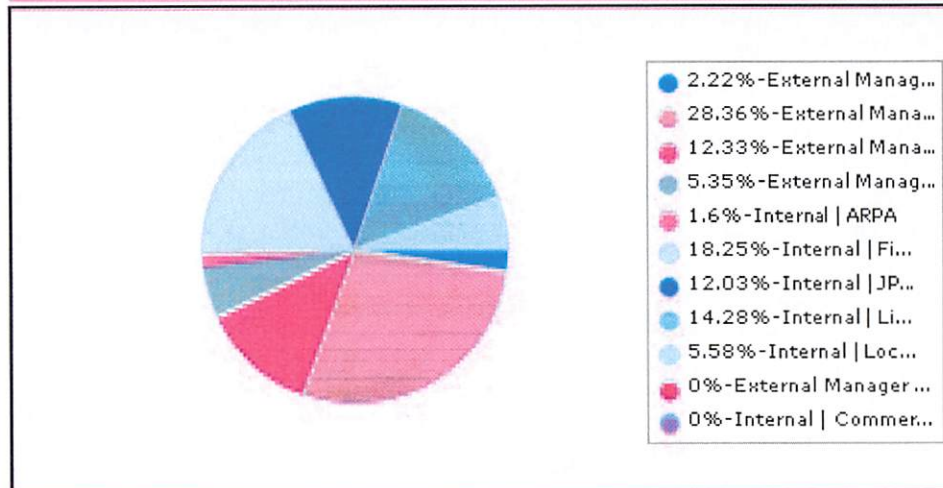

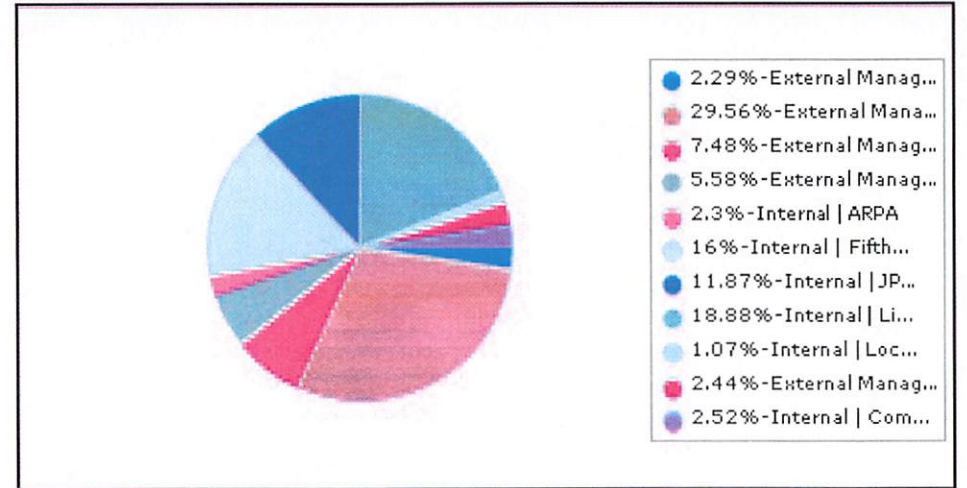
