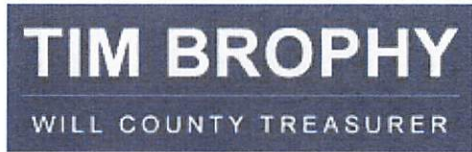

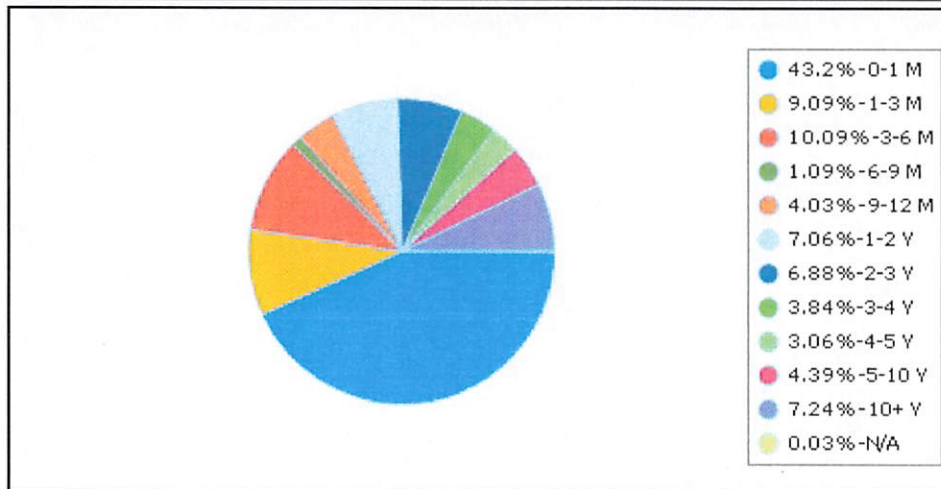
Will County Distribution by Maturity Range - Market Value All Portfolios

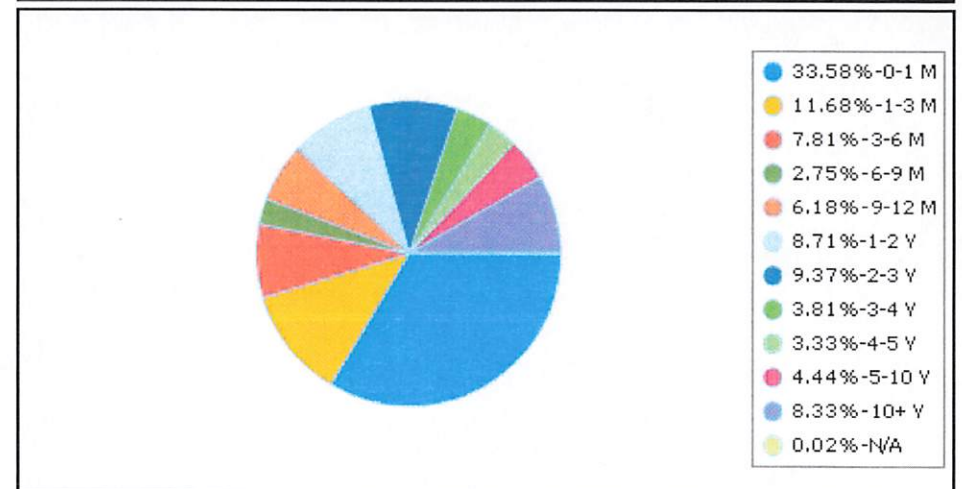

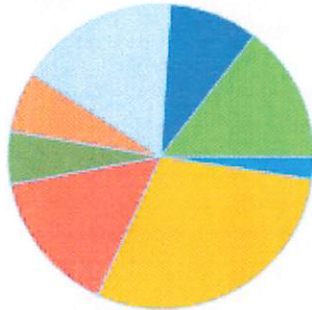
Will County Distribution by Main Fund - Market Value All Portfolios

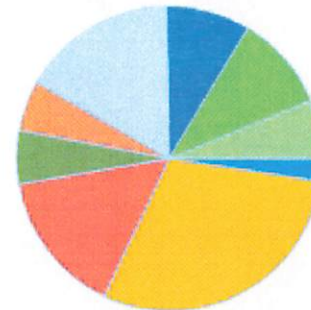
